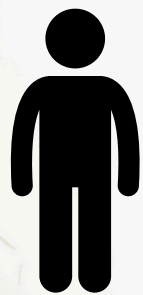

# BRITAIN

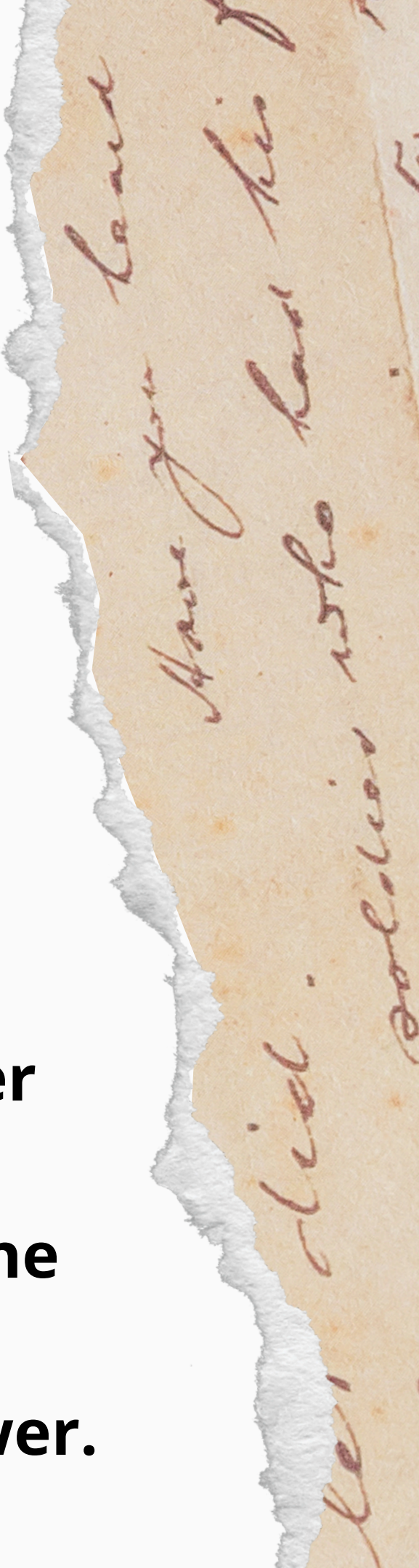
**Britain has a long and interesting history.**

# IRELAND

**He taught people about Christianity.  
Today, he is the most famous saint in Ireland.**

**Every year, people celebrate St. Patrick's Day on March 17.**

**Later, Vikings came to Ireland from Scandinavia.**

**They built towns like Dublin. After the Vikings, the Normans came from England.**

**They took control of many parts of Ireland.**







**For many years, England ruled Ireland.**

**Irish people were not happy, and there were many fights and problems.**

**In the 1800s, a terrible event called the Great Famine happened.**

**Many people had no food, and over a million people died.**

**Many others moved to other countries, like the United States.**



**In the early 1900s, Irish people wanted  
independence from Britain.**

**In 1916, there was a big event called the  
Easter Rising.**

**After that, there was a war.**

**In 1921, most of Ireland became  
independent.**

**This new country is now called the Republic  
of Ireland.**

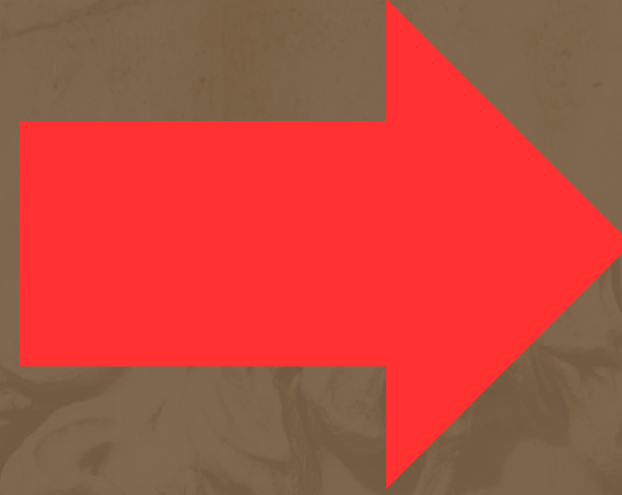
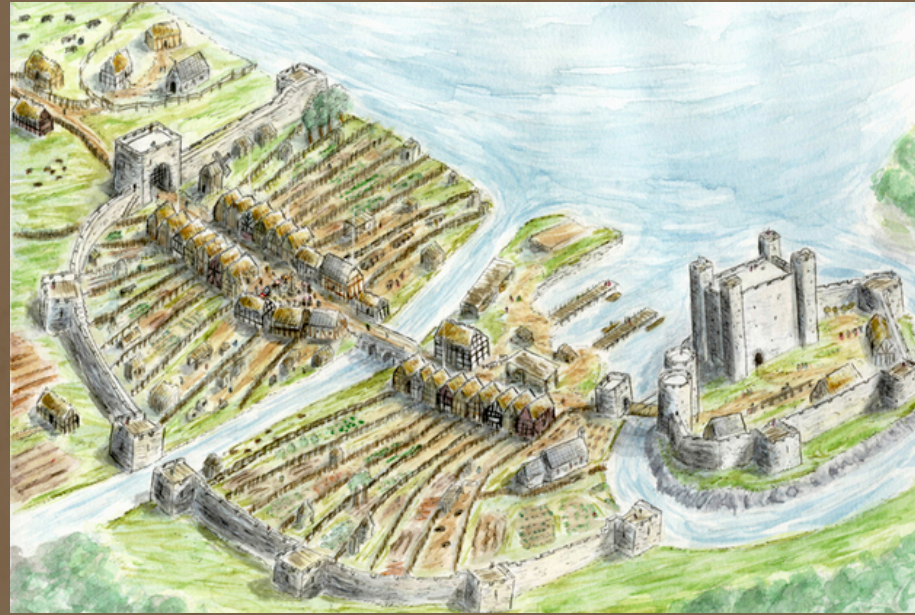
**But part of the island, called Northern Ireland,

**This period was called The Troubles.  
It ended in 1998 with a peace agreement called  
the Good Friday Agreement.**
